The CLASS Curricular Development Grant is intended to fund and support new courses that promote the curricular goals of the department/program and the College. Proposals will be evaluated based upon the following:

1. The proposed course's potential for curriculum expansion

2. Course alignment with a strategic disciplinary area

3. Will the proposed course be building onto a cluster of other courses to satisfy a major and/or minor at the undergraduate level or graduate level?

What the Grant Will Fund

Support will be given strictly for curriculum development (e.g., educational resources, software materials and any reasonable and necessary expenses in support of the project).

What the Grant Will Not Fund

Expenses incurred outside the scope of the proposed curricular development will not be funded or reimbursed.

Eligibility

All CLASS faculty currently employed at UH are eligible to apply.

Application Requirements

Applications shall consist of:

- Signed Cover Page (template provided)
- Project Description- Maximum 2 pages, double- spaced, 12 point font
- Project Budget and Justification (template provided)
- Applicant(s) CV- Maximum 2 pages per applicant
- Letter of Support from the Department Chair

PLEASE NOTE: Incomplete applications will not be reviewed. Applications will be considered incomplete until all information has been received, at which time an email confirming receipt will be sent to you.

Proposal Guidelines

Project Description: Please provide a brief description of the project, detailing the potential impact and how it enhances the curriculum. Project descriptions should also include:

- **Key Personnel:** Identify specific faculty members designated to oversee the project.
- **Implementation:** Provide a brief explanation of how you intend to implement the project in addition to an evaluation plan (e.g., student surveys, peer reviews).

Project Budget and Justification: Be sure to provide an itemized budget (template provided) along with a budget justification for all expenses to be covered by the grant.

PLEASE NOTE: CLASS Curricular Development Grants are for a maximum <u>12</u> months. Any unused funds at the end of the project period will be returned to CLASS at the end of the grant period.
