No Confidence in HigherOne

Whereas, HigherOne and The Bancorp Bank were ordered by the Federal Deposit Insurance Corporation (FDIC) to return \$11 million (\$11,000,000) to approximately 60,000 students in August for unfair and deceptive practices (in violation Section 5 of the Federal Trade Commission Act- Section 5), and

Whereas, The Federal Deposit Insurance Corporation was also ordered to pay \$110,000 for civil money penalties and The Bancorp Bank \$172,000 for civil money penalties, and

Whereas, HigherOne provides refund cards to University of Houston students receiving financial aid, and

Whereas, Students receiving financial aid are sent a HigherOne MasterCard after they are admitted and prior to the first day of class and indirectly pay for the card, and

Whereas, the University incurs a transaction cost for every student refund sent to HigherOne and students indirectly pay for the transaction cost, and

Whereas, students are charged a fifty (\$0.50) cent fee every time a card is used as a debit transaction, and

Whereas, the fifty (50) large four-year (4) public institutions by campus population use other third party providers such as Wells Fargo or CitiBank, or handle refund services in-house, and

Whereas, The University of Houston students would like to forego business with any company who does not practice the utmost ethical standards

Furthermore, the University of Houston Student Government Association urges the University look to provide financial aid refund services through current administrative modules or contract services with another provider.

Be it finally resolved:

That the University compels HigherOne to provide students with a pamphlet of information regarding any and all fees associated with the CougarOne card accounts.
