## **Bylaws Adjustments**

Whereas, there are slight adjustments that can be made to the bylaws that can significantly increase clarity on regularly conducted procedures in student government;

Whereas, it usually takes approximately twenty-four (24) to fourty-eight (48) hours to verify the eligibility of candidates who have applied for officer roles requiring confirmation by the Student Government Senate;

Whereas, contact between officials within or outside of the student government is usually more difficult to conduct on Saturdays and Sundays;

Whereas, reports for officers are missing from the order of business section;

Whereas, the student government and the student populace would benefit from allotting representatives of university committees to report to the senate on a regular business;

Whereas, the Emerging Leaders program needs to have involvement between senate leaders in the executive in mentorship of student government interns;

Therefore, be it enacted by the Senate of the Student Government Association of the University of Houston: **Be it further enacted,** Title II: Rules of the Senate, Article I: Order of Business, Section 1: The order of Business for all regular meeting of the Senate will be as follows:

"Clause 1: Call to Order by the Presiding Officer

Clause 2: Reading and approval of the Senate minutes from the previous meeting

**Be it further enacted,** Title I: Composition and Structure of the Senate, Article 8: Committees of the Senate; Section 1: General Provisions, Clause 11 be added to read:

"Clause 11: All Chairpersons and the Vice-Chair of each Senate Committee will serve as a mentor in the Emerging Leaders Program";

**Be it further enacted,** Title II: Rules of the Senate, Article I: Order of Business, Section 2: Distribution of the Senate Agenda and Deadline, Clause 1 be amended to read the following:

"Clause 1: The Senate Agenda will be distributed two (2) days prior to the Senate meeting on the preceding Monday by 7pm.";

Be it further enacted, Title III: The Executive, Article 2: Executive Appointment Process, Section 1: Appointment Process, Clause 4 be added as the following:

**Be it further enacted**, Title VI: Fiscal Policies and Procedures, Article 3: Fiscal Procedures, Section 2: Submittal Procedures, Clause 1 be amended to read the following:

"Clause 1: Any purchase over \$500 can be subject to review with the discretion of the Internal Affairs committee."

**Be it further enacted,** Title VIII: Student Fees Advisory Committee, Article 3: Appointment of Student Members, Clause 1 be amended to read the following:

"Clause 1: Student members will be appointed by the President, the Vice President, or the Speaker of the Senate of the Student Government Association, with the advice and consent of two-thirds (2/3rds) of the Student Government Association Senate present and voting."
