### Clause 8: New Business

# I. The Reasonable Accommodation for Graduate and Professional Students Act (SGAB-54006; Override)

- Implementation of a Graduate Committee that works around graduate students' schedules
- Allows graduate senators to not be held to a set number of attendances
- Accomodations implemented by this bill will work in the favor of graduate students and will incentivize their participation due to the less intensive restraints

#### II. Stipend Policy Readjustment Act (SGAB-54005; Override)

- Bill gives way to go through a court process if a problem with the stipends is noticed
- Bylaw changes introduced makes it so that refunds on part of misused stipends can be fulfilled
- As of now, no real regulation regarding such, which is why the bill is needed
- Bill is ultimately meant to act as a checking system on the executive branch
- While said introduced bylaws are already present to a degree in legislation, there is a lack of specificity which can lead to abuse of the policy
- Current system allows for loopholes and gaps to be exploited

#### III. Transparency Act (Override)

- Bill was previously passed with overwhelming support from the senate, but was vetoed
- Bill will allow us to see in depth as to how the money being provided is being spent by the executive branch
- Allows us to see where money is being allocated
- Will allow students to view the transactions as well

#### IV. Social Media Act

- Was previously voted on and passed, however was vetoed
- Makes it so that the Student Government Association of the University of Houston will now have a social media platform and a Linkedin page with which they can communicate more directly with the student body
- Linkedin page already exists due to the bill passing previously, so it only makes sense to reintroduce and pass the bill once again as the outcome of such is already present
- While the page is already up and running, this bill will make it so that it is required for it to be maintained *Motion for a Moderated Caucus for 2 minutes with 30 second speaking time ::: Motion Fails*

#### I. Comments and Announcements from Officers

#### Senator Shofoluwe
