VII. Modern Drug Policy Act (First Read)

- Harris County has decriminalized marijuana and overdose is virtually impossible on the substance
- Worst punishment for possession or consumption of illegal substances should be expulsion not jail time; Expulsion would not be the first response
- Distinction must be made between distribution and possession
- Would shift focus from persecution to therapy and counseling
- Will not form a culture of promoting drugs but would act as a "harm reduction" policy
- Act would not prevent police from arresting individuals but would make sure administration would not immediately call the police on individuals possessing illicit substances

VIII. Food Inclusion Act

- FSAC looking at implementing halaal and kosher food
- This act would make it so that those with restrictive diets would be better provided for and have more options
- Every new building/dining hall will have a halaal and kosher option put into place
- Discussions currently going on with auxiliary services, if any amendments need to be made they will be done during the summer senate

IX. Involvement Act

- Would require RSOs to update meeting times and contact information on the "Get Involved" page
- Would make the process of becoming an RSO easier but would make it harder to maintain that position
- SOLAR training no longer required for repeat RSOs trying to maintain their position, only needed for their first time
- Will still allow for liability trainings
- Implementation of separate systems that will allow for the easier upload of new organizations into "Get Involved"

X. Parking Relief Act

- Increase in parking rates will be capped at 8%, emergency increases must be declared to the student body
- Schedules must be released more than a year in advance
- Will require there to be an actual necessity in order to increase the parking rates
- Better communication to both staff and student body regarding changes with the parking situation and rates

XI. Election Reform and Fairness Act

- Modifications will be made dependent on the turnout during the upcoming election

- Changes voting days to be spread over three weeks with the first week being Monday and Tuesday, the second being Wednesday and Thursday, and the third being Friday and Saturday
- Modification of voting days would allow for a break for both the student body and the election parties
- Sunset clause implemented which states that if the Act fails to improve upon the current system, the change will be rescinded
- One trial year to see how this will pan out
- Voting would open for 48 hour periods during the 2 main rotation days
- New Chief Investigator Position created
- If a presidential candidate or vice presidential candidate drops out, the election party is no longer required to drop out of the race
- Expenditure limits will be implemented
- Three new polling locations will be created to allow voting on campus
- Presidents are not allowed to run again for a second term
