#### VII. FY19 Budget Bill (First Read)

- Lowers banquet expense from 3K to 2.5K
- Increases the Senate's Budget
- 14% of budget is now allocated towards election time
- Deadline to pass Budget Bill is by December 30th

#### VIII. Menstrual Product Price Stabilization and Availability Act (First Read)

- Act reduces the amount of inflation on menstrual products on campus
- Will bring in more options regarding these types of products on campus
- Act will increase quantity and brands available
- Act will standardize the prices across University of Houston rather than having certain stores on campus be higher or lower
- Act will address the issue of sustainability regarding buying these products on campus

## X. The Bylaw Update and Structural Reform Act

- Will result in consolidation of the justice department
- Will remove the required Office Hours posting
- Removes the Sergeant at Arms position
- Meeting hours now count as Office Hours
- Prevents random suspension of bylaws
- Will check the executive branch by allowing the senate to overturn executive propositions
