VII. The Inappropriate Consensual Relationship Act (First Read)

- Will also add more specificity to the University Policy already in place
- Ultimately final decision will be made by the Director

VIII. The Structural Reform Act

- Introduces a new set of bylaws
- Biggest change being implemented is with the justice department, the new bylaws separate the justice department from the executive branch
- Finance Director will now be under Outreach
- Senate will now have authority over the senate budget
- There is currently no formal process for Bills, working on making one

IX. The Modern Drug Policy

- The Drug Policy will make it so that the outcome of finding a student intoxicated will not be dependent on how the staff/faculty feel that day, will make it so that there is only one consistent response
- Makes the distinction between possession and distribution
- Policy has already been in talks around the Dean
